**COMMITMENT**

The Leadership Lee County program consists of nine monthly seminars and a retreat. **Each participant is required to attend the opening retreat which will be held September 14-15 (no overnight stay is required), and the full-day seminars on the second Thursday of the month from October through May (unless otherwise noted). Any participant with two or more absences will not receive a diploma from the program. If you are unable to make such a commitment, it is not in your best interest to apply at this time.**

Tuition for the 2011-2012 program is \$650 and covers all program costs, including materials, meals, transportation and the retreat. If accepted into the program, the nominee will be billed for the tuition in full to be paid by the individual or his sponsoring organization by the October Program Date. If full tuition payment is not received by the October Program, a \$25 late-fee will be added to the remaining balance. No tuition will be refunded in whole or in part after the Opening Retreat has begun. All applications, including scholarship applications, must include a \$25 non-refundable application fee which will be applied toward tuition payment if accepted into the program.
